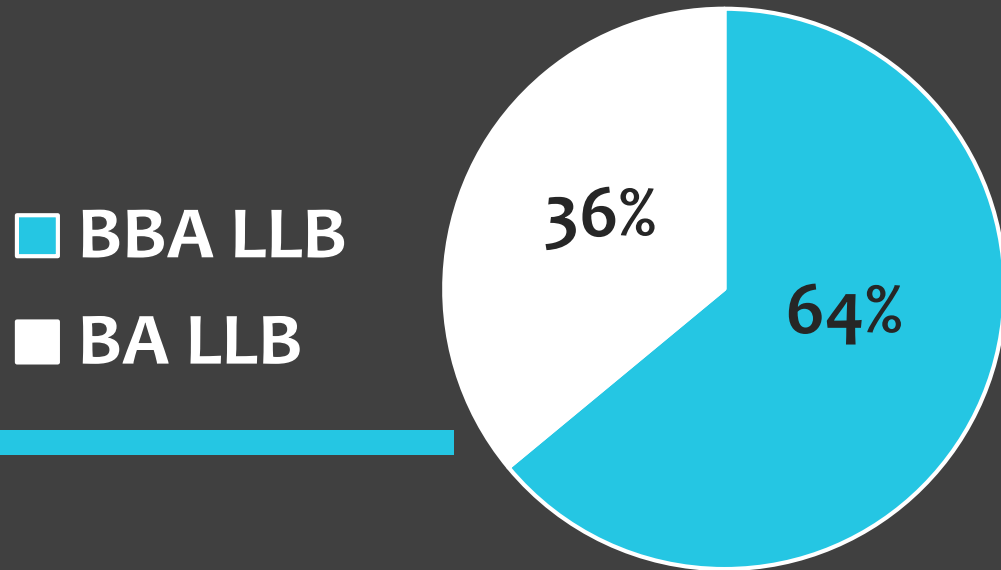
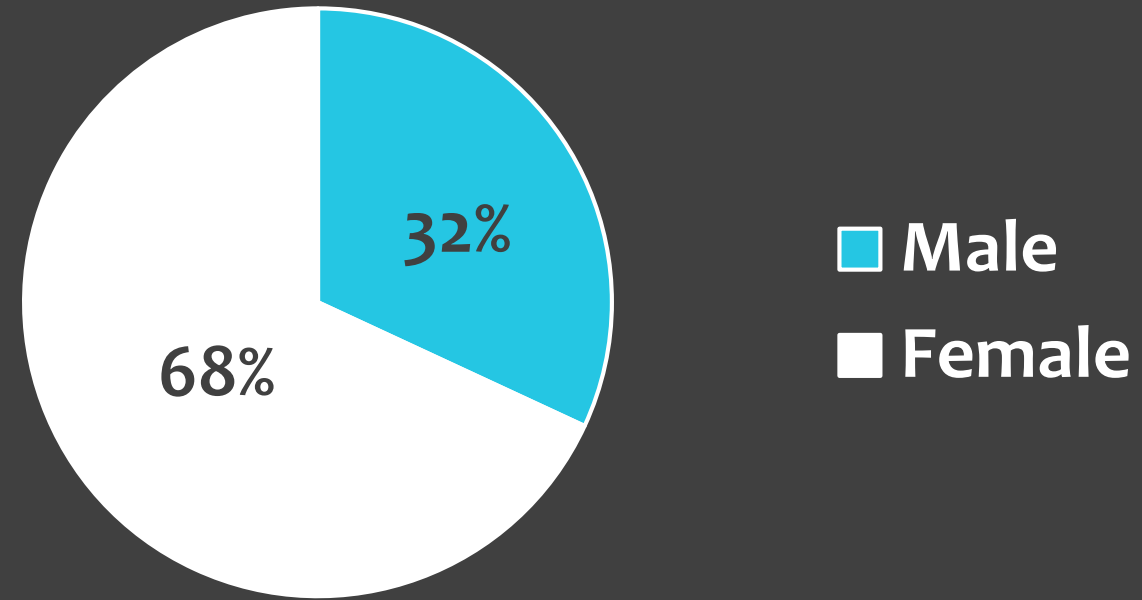

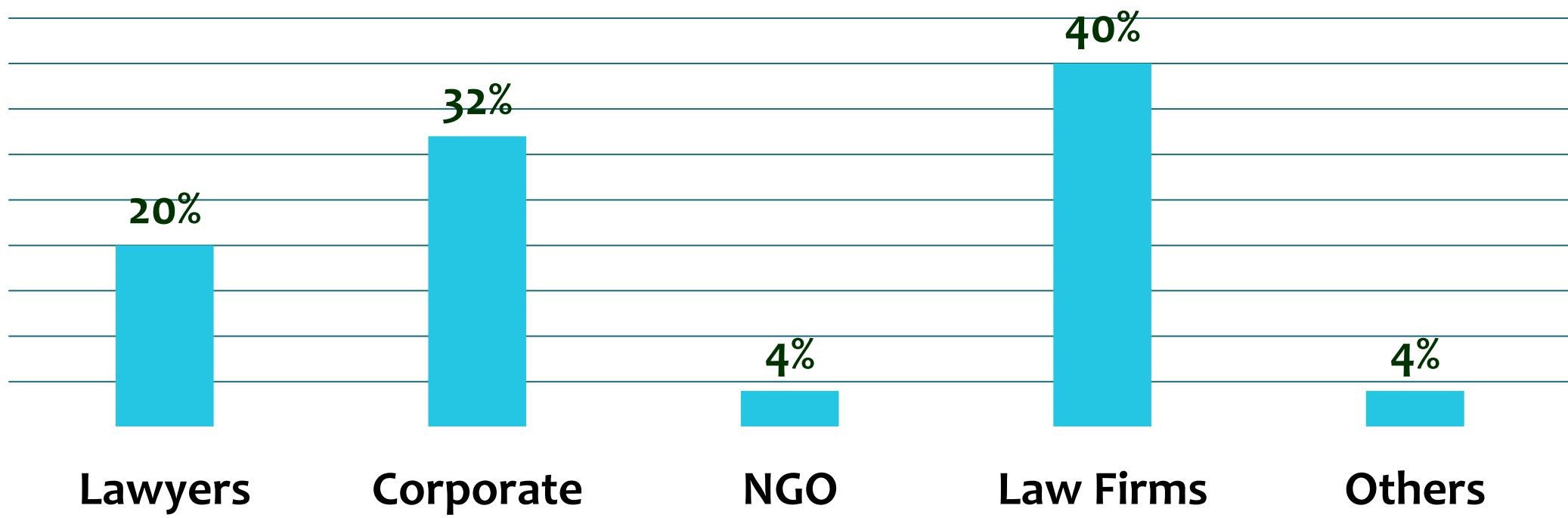
Gender Wise

Of the Candidates who have been placed this year, 68% are females while as 32% are males.



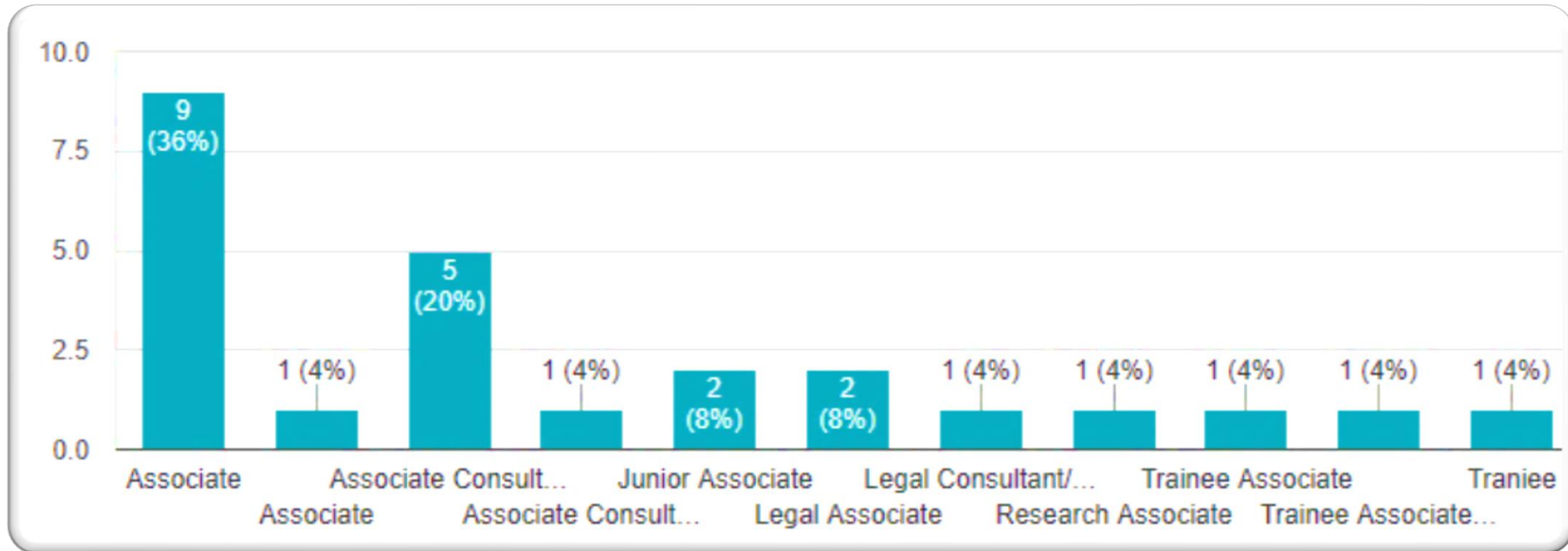
64% were from BBA LLB while as 36% were from BA LLB. The programme-wise placement details are discussed in the pie chart.

From a total of eligible students, who got Placement, 40% have secured it in the Law Firms, 32% accepted the offer from Corporate Sector, 20% got placements with Advocates/ Lawyers & AOR , 4% received offer from NGO while as 4% from other sectors. Law Firms being the top recruiters by offering placement followed by Corporate Sector as the second-highest recruiter.

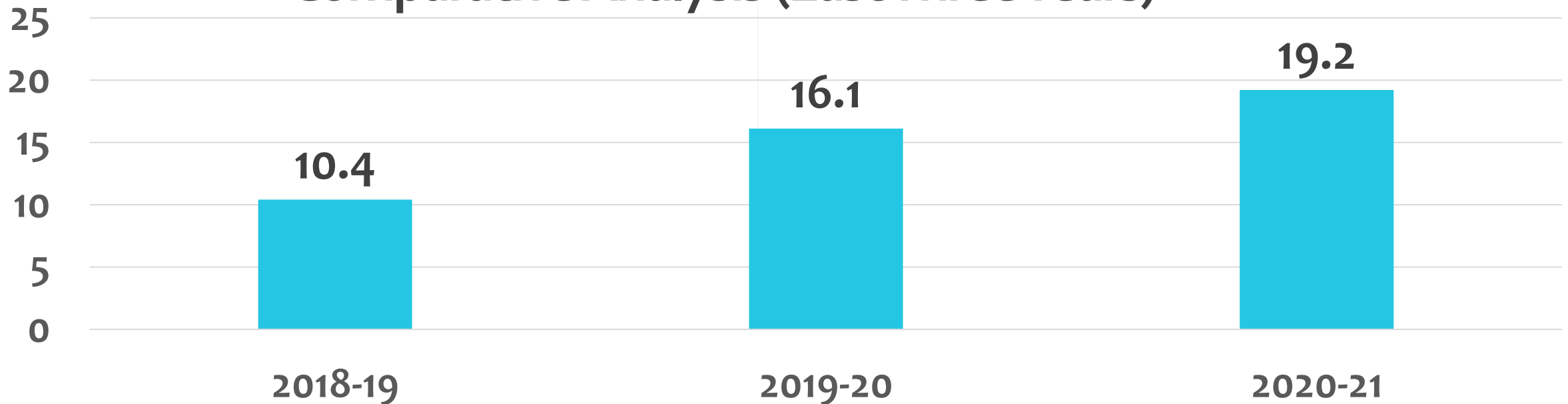

Key Highlights of Batch 2016-2021

The highest CTC stood up to Rs. 19.20 LPA.
The average CTC stood up to Rs. 10.80 LPA.
The lowest CTC stood up to Rs. 2.40 LPA.

CTC for the top 10% of the batch stood up to Rs. 19.20 LPA.
CTC for the top 25% of the batch stood up to Rs. 9.60 LPA.
CTC for the top 50% of the batch stood up to Rs. 4.80 LPA
CTC for the top 15% of the batch stood up to Rs. 2.40 LPA

Comparative Analysis (Last Three Years)



Average CTC at SLS-N has seen a continuous rise over the past three years going from 10.40 LPA (Lakhs per annum) in 2019 , 16.10 LPA in 2020 19.20 LPA in 2021. Interestingly, the highest salary numbers do not show a different story even in the pandemic year. The highest salary at SLS-N has also been constantly increasing over the past three years.

- The placements process at SLS-N saw participation from 100+ recruiters out of which 10+ were first time recruiters.

- To give you an idea state wise, these students were placed at different locations in the states like Delhi, Uttar Pradesh, Maharashtra and Haryana. Delhi NCR provided the maximum opportunities of followed by Maharashtra.
- Union territories also gave a fair chance to the students. NCT of Delhi absorbing almost 95.2% students while as leaving only 4.8% for Chandigarh.
