

**SYMBIOSIS LAW SCHOOL, NOIDA | MOOT COURT SOCIETY****Mooting Achievements 2022-23****[In Reverse Chronological Order]**

1. **3rd HPNLU Moot Court Competition in association with NHRC, 2022:** organized by Himachal Pradesh National Law University, Shimla from October 28 -30, 2022

Mr. Vinayak Takkar, Mr. Tanishq Jakhar and Mr. Rahul Jain, Second Year Learners participated in the competition and were adjudged to reach the **'quarter-finals'** stage of the Oral Rounds.

78 teams across India participated in the Competition, out of which 32 were invited to participate upon a Memorial Selection Round. The rounds took place offline, on their campus in Shimla. The moot problem was based on obscenity under the Indian Penal Code, 1860, the validity of a hypothetical personal law, the hierarchical scheme of the Fundamental Rights, Article 19 of the Indian Constitution, Constitutional validity of the Unlawful Activities (Prevention) Amendment Act, 2019 and right to access the internet under Article 21 of the Constitution.

2. **5th National Insolvency Moot Court Competition:** Organised by Surana and Surana and UPES School of Law on 14th-16th October, 2022

Mr. Amulya Bhatia, Mr. Sidharth Grover, Fourth Year Learners and Mr. Ayush Tiwari, Third Year Learner participated in the competition and were adjudged **'Runners up'**, reaching the Finals and was also awarded cash prize of **Rs.15,000**. Mr. Amulya Bhatia was adjudged as the **'Best Student Advocate'** and was awarded a prize of **INR. 5,000**. Mr. Sidharth Grover was adjudged as the **'Third Best Student Advocate'** and the team also adjudged for drafting the **'Third Best Memorial'**.

14 teams participated in the competition. The rounds took place virtually. The Moot problem was based on Insolvency and Bankruptcy Laws applicable in India dealing with issues pertaining obligations of a corporate guarantor, Sale

of unencumbered assets and jurisdiction of National company law tribunal, withdrawal of resolution plan and the validity of notification directing sale of the corporate debtor as a going concern.

3. National Moot Court Competition 2022: organised by Symbiosis Law School, Nagpur from 14th-16th October, 2022

Mr. Dhruv Soni, Mr. Keshav Chawla and Ms. Priya Darshini S, Second Year Learners participated in the competition and were adjudged '**Semi-Finalists**' and were also awarded the '**Best Memorial Award**'. The team was also awarded with a **cash prize of INR 7,500**.

An initial Selection round for Memorials was conducted for all teams and Top 10 teams were selected for the Oral Rounds which were conducted from October 14th to 16th. The Oral Rounds took place in offline mode at SLS Nagpur. The Moot problem was based on Arbitration and Conciliation Act, 1996 and the power of court to set aside and modify the Award passed by the Arbitral Tribunal. It also dealt with the contractual obligations of the parties according to the Indian Contract Act, 1857.

4. 11th Nyayavalokan National Trial Advocacy and Judgement Writing Competition, 2022 was organized by SVKM Pravin Gandhi College of Law, Mumbai from 6th October 2022 to 9th October 2022.

Ms. Suchitra S Menon, Ms. Anudha Singhai, Ms. Ishita Nagpal, and Ms. Ananya Nigam, Second Year learners participated in the competition and qualified for the '**Quarter Finals round**' of the competition.

24 teams from all over India participated in the competition and after two preliminary rounds, only 8 teams qualified for the Quarter Finals. The problem of the competition was based on a hypothetical situation which encompassed Sections 304(b)- Dowry death, 306 – abetment to suicide and 498(a) – Cruelty by the husband and the relatives of the husband of the Indian Penal Code, 1860, along with relevant provisions provided in the Indian Evidence Act, 1872 and the Code of Criminal Procedure, 1973..
