## Sector Wise

From a total of eligible students, who got Placement, 53% have secured it in the Law Firms, 26% accepted the offer from Corporate Sector, 12% got placements with Advocates/ Lawyers & AOR , 2% received offer from NGO while as 7% from other sectors. 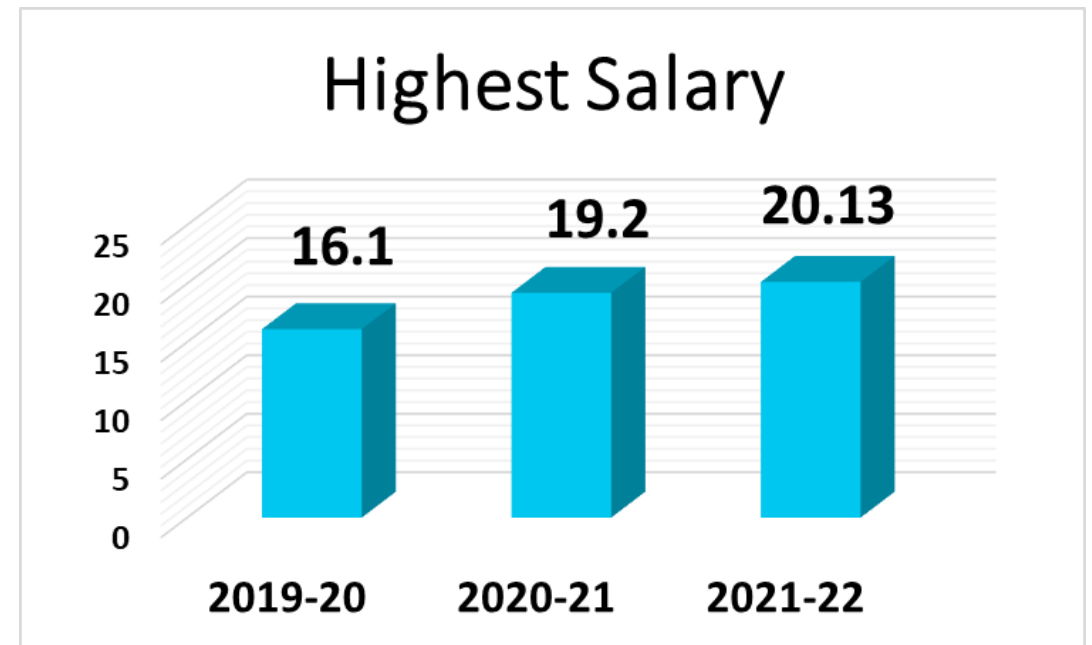
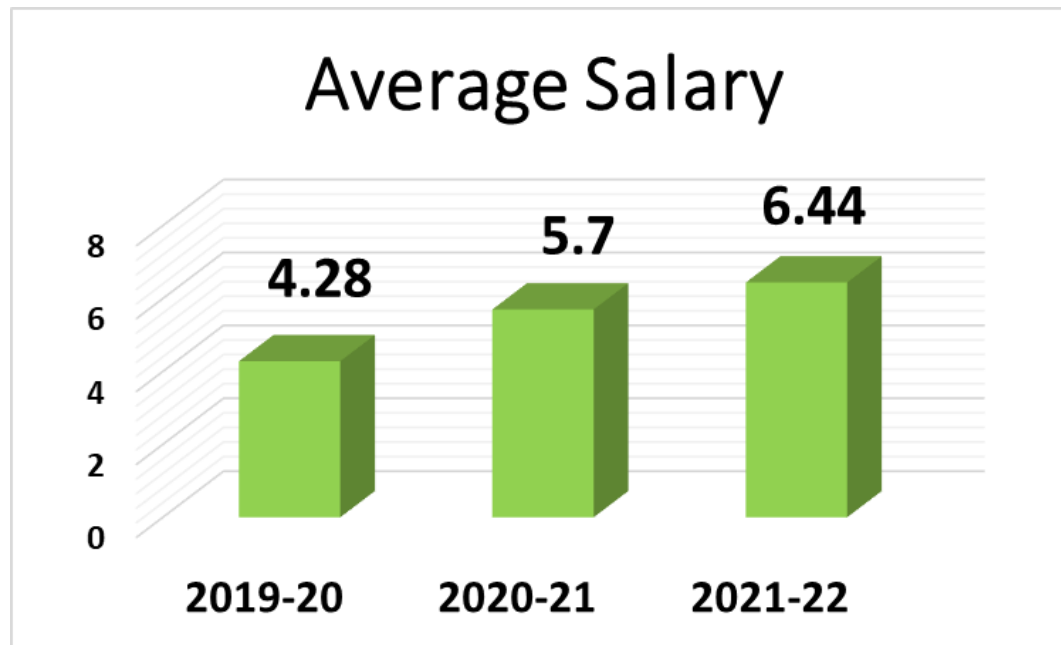

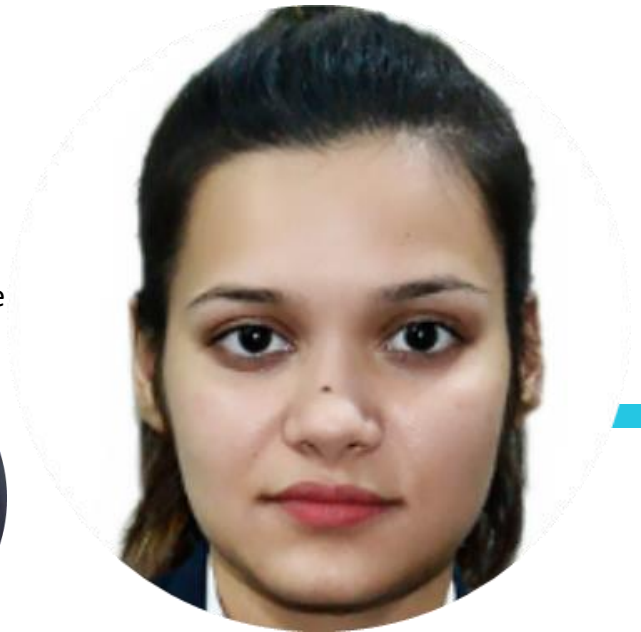
