

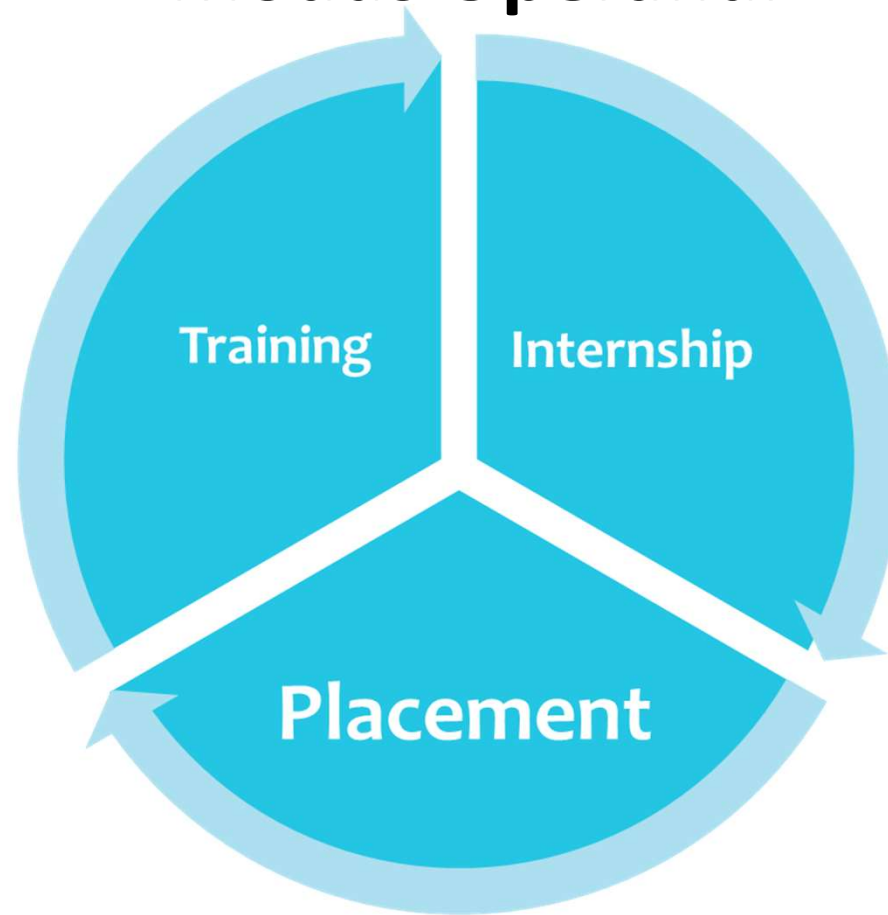

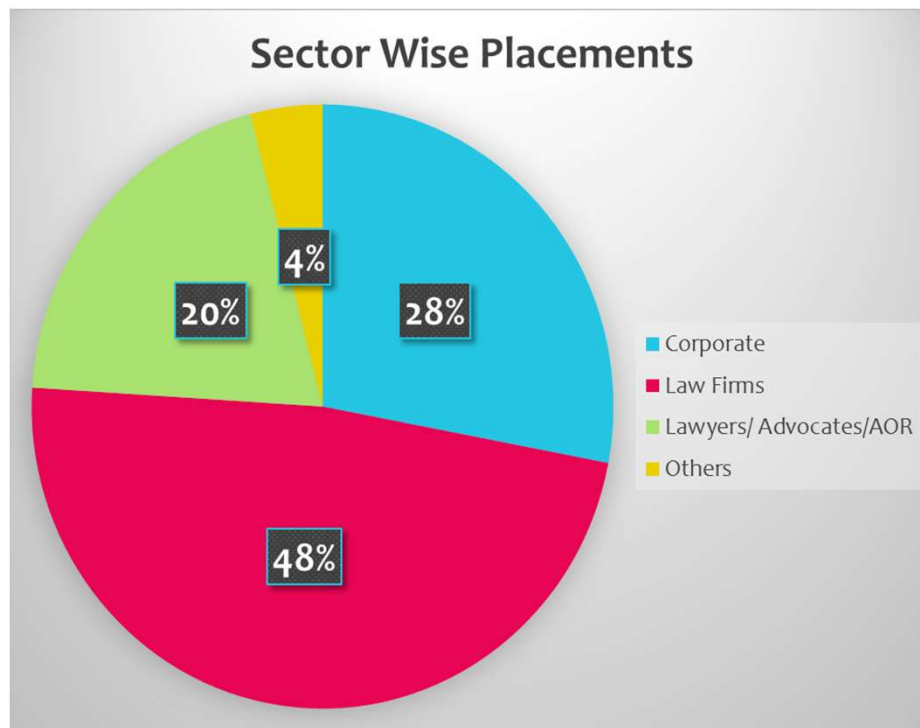


# Placement Process Overview

- **Placement Cycle:** Begins in 4th year after LEAP.
- **Registration:** Done on Superset portal, exclusive for placements and assessment internships.
- **Internships/PPO:** Opportunities available alongside placements for practical experience.
- **On-Campus Drives:** Conducted regularly by companies/law firms visiting the campus.
- **Opportunities:** Students can directly interact with recruiters during these drives.



# Highlights: Sector wise



- From the total eligible students who got placement:
- 48% secured placements in Law Firms.
- 28% accepted offers from the Corporate Sector.
- 20% got placements with Advocates/Lawyers & AOR.
- 3% received offers from other sectors and NGOs.
- Law Firms were the top recruiters, offering the highest number of placements.
- The Corporate Sector was the second-highest recruiter.
