"LEGAL AWARENESS EVENT: HUMAN RIGHTS DAY" (Report on the event conducted in Karnal, Haryana; December 10, 2018)

An informative event was conducted by LAC volunteer, Ms. Meghna Rana from legal aid centre, SLS-N. The college students were informed about the laws against trafficking of women.

1. Concept Note:

The Legal Aid Centre at Symbiosis Law School Noida organized legal literacy campaign on the Human Rights Day i.e. 10th December 2018. In this campaign the members were assigned the responsibility to conduct a legal aid event in their home towns. As a LAC volunteer I conducted this program in KVA DAV college for women, Karnal, Haryana. This programme was conducted to spread awareness to the girls of rural background regarding trafficking of women.

Trafficking of women for prostitution, bonded labour, domestic labour etc. Is a menace in India especially in the rural belts where lack of awareness and hurdles in access to justice becomes an advantage for the trafficking network. The numerous laws against human trafficking have many provisions to punish those who traffic innocent girls and women. Immoral Traffic Prevention Act, 1956 aims to combat trafficking and sexual exploitation for commercial purposes. The Indian Penal Code, 1860 has many sections which specify punishments and penalties against trafficking like kidnapping, abducting or inducing women to compel her for marriage (Section366), selling minors for purposes of prostitution (Section372), buying minors for purposes of prostitution (Section373) etc. Various laws ensure protection of women but their awareness and understanding is a major problem which can be addressed through such campaigns by law students who can always contribute to the society.

2. Objective:

The main objective of this campaign was to create awareness and educate people about human rights. Many people are not well versed with their rights and are not aware of the means to safeguard their rights.

- To explain the formation and working of human trafficking networks
- To introduce the girls to the important laws which should be included when FIR is lodged
- To make girls aware about the consequences of ignorance of such laws
- To explain the points to be paid heed while reporting
- To motivate everyone to report cases whenever and wherever they witness

3. Preliminary Preparations:

- A PowerPoint presentation on the important laws
- Meeting with the principal of the institute to understand the background of the girls
- Discussion with the faculty to understand the needs of the girls
- Read articles on human trafficking
- Read about laws against human trafficking
- Viewed interviews of NGOs working against trafficking of women
- Viewed interviews of victims of trafficking

4. Conducting the program:

The event was organized in KVA DAV college for women, Karnal which offers courses for students from humanities and commerce stream. All the girls happily attended the session as it was a new theme for them. The LAC volunteer commenced the event by introducing the legal aid centre of SLS-N and its functions. Then a short video clip of a lady from Haryana was shown which disclosed the bitter truth behind the rise in trafficking cases. Then the working of human trafficking networks was explained along with the ways to identify them. This was an interactive session where two girls shared their personal experience of being stalked. One of the teachers shared an incident of the kidnapping of her friend's child and how he was rescued from a factory. This was followed by explanation of the Immoral Traffic Prevention Act, 1956 and some sections of the Indian Penal Code, 1860. The main emphasis in their explanation was put on certain provisions. The recent amendments in this act were also explained. In the end, the principal and a faculty member gave a short speech in which they emphasised on the importance of understanding of laws and motivated the girls to read more about the same. They also thanked LAC for such a nice initiative.

5. Response of the target population:

Around 30 girls and some faculty members attended the event. The girls listened attentively and did understand the main points I wanted to convey. Around 80 percent of the girls were from the rural belt and had

witnessed such incidents but they expressed that had they known about the NGOs they would have reported the cases. The girls were motivated to help any way they could. They also came to talk personally after the event was over to understand about DLSA in collaboration with which LAC works.

6. Future plan of action:

Only one brief event about certain laws is not adequate. More events by experts are required to fully equip the girls to protect themselves and also to report cases.

7. Suggestions/Feedback:

- Some experienced volunteer should explain how the NGOs work in rescuing the girls.
- A legal expert should explain the girls the importance of remembering the relevant laws and the provisions so that the girls can make effort to memorise the important procedures.
- A legal expert should also share some cases where these laws have been applied.

8. Conclusion/Remarks:

This event not only helped in creating more awareness regarding laws but also helped in understanding the ground realities. It also helped in reading and understanding certain new laws which I had not read so far. Being a novice in the field of law, I feel that this experience was the first


step in understanding and analyzing the truth of the society. It is my duty as a LAC volunteer to contribute to the society, and this experience was my first step in this contribution. The interaction with the audience was really helpful for me to understand how well had I explained the laws as well as how much had the audience grasped the essence of what I wanted to convey.


9. The Most Touching Moment:

I was really happy that the girls understood that I had made efforts to spread awareness and help them become more strong by learning the laws.
