## **REPORT**

### **“Project: WAZIFA”**

#### **CONCEPT NOTE**

Through this event we aimed at educating the rural population about the scholarship schemes available to them for completing their education. We see various schemes available for the students of lower strata of the society who are unable to complete their education. The main motive of this event was to make the target audience aware of those schemes and how to avail them.

The audience had a mixed batch of people, with mixed type of thinking and the team thought of it to be extremely important to open up their minds to education and the prospects that it brings.

Instead of going ahead and telling them about all the various scholarship schemes available, the team decided to explain two schemes in depth and detail so that there is no confusion.

The pamphlets prepared by the team were in Hindi, to make sure they can be understood by the audience even at their homes.

#### **OBJECTIVE OF THE EVENT**

- Making the workers/helpers aware of the scholarship schemes available.
- Explaining to them whether their children fit into any of the two schemes and how to apply for them.
- Aiming for more and more people taking advantage of the schemes and having more and more educated people in the country with a better future.

#### **PRELIMINARY PREPARATIONS**

The team researched on various scholarship schemes that are available and decided to go ahead with two schemes, explaining them in depth to the target audience the importance of completing one's education.

After the research was done, we made pamphlets, designed and step wise explained about what the scheme is and other pertinent details and got the pamphlets for Pre-matric and Post-matric schemes separately.

## **CONDUCTING THE EVENT**

The event was conducted in the afternoon in batches of 2. One batch was that of house help mothers. The second batch was watchmen and other house helps.

The team asked the audience questions like whether they have children, what age are they, are they enrolled in any school or not, whether their children dropped out of the school. The team refrained from asking the reason if the children had dropped out of school, to not make them parents live through that situation again.

Then according to the answers to the questions, we categorized their children into Pre-matric students or Post-matric students.

After all this evaluation, the team explained to them about scholarships and the right of education that is free till primary education. After briefing them about all of this, the team read out the entire pamphlet to them and explained each point in detail. The pamphlets were then given to the audience since it contains steps on how to apply for these schemes. We also made sure to tell them how they can contact us if they ever need help with the same.

## **RESPONSE OF THE TARGET AUDIENCE**

The target audience was all the house helps, housekeeping workers and guards in the team's locality. We were elated to see interest that some of the audience members showed. Whereas, there were certain members of the audience who were not as keen and hesitated because of their economic condition. As a whole, we were able to satisfy all the audience questions and make them aware of the two schemes in focus.

## **FUTURE PLAN OF ACTION**

Apart from being available for the people who will contact us with queries, the team is planning to use the pamphlets in the future and making extension of the pamphlets by correcting the content that maybe confusing and making pamphlets for other schemes available as well. Due to covid, the team was not able to reach a larger audience, but they plan to have a bigger version of the event once the lockdown from Amphitheatres and clubs is lifted in their respective localities.

## **CONCLUSION AND REMARKS**

This was a lovely experience, by way of which I could attempt to make a difference in the lives of people. It was lovely to see how the parents who are themselves not educated striving hard for their children to have a better life. Contributing to change someone's life, even in a small capacity is a heartwarming experience and I'm grateful to the LAC for providing me with this opportunity.

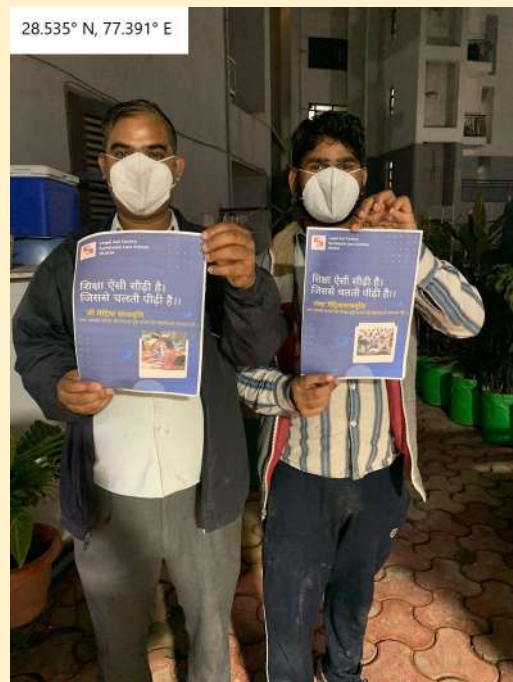
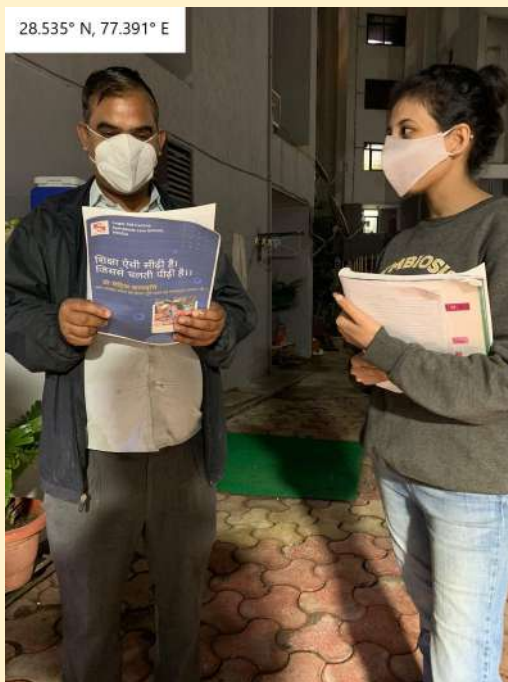
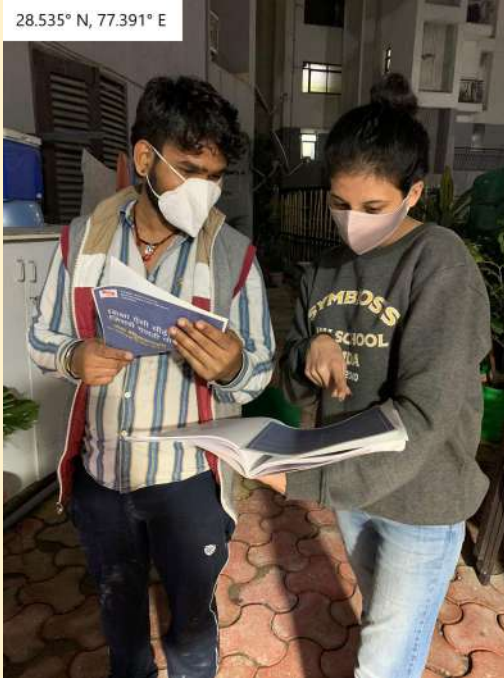
