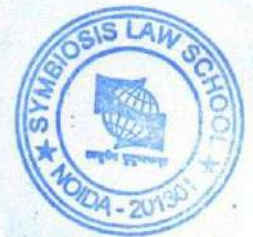

13. Description of Event (max. 250 words)

The Jan Sunwai event, held on 21st and 22nd September 2024 in the slums of Rasoolpur Nawada, NOIDA, aimed at empowering underprivileged communities by providing crucial civic and financial services. Over the two days, the event focused on helping residents, particularly those from the Valmiki Samaj, gain access to essential identification documents such as voter cards, PAN cards, ABHA health cards, and Aadhaar-related assistance. A significant collaboration with SBI enabled the opening of bank accounts, including Sukanya Samridhi accounts for girls, to promote financial inclusion and security.

In addition, grievances related to basic public amenities such as clean water and sanitation were documented, and forms were filled on behalf of residents. These were later submitted to the Noida Authority to ensure action and improvements in living conditions. On the second day, a street play was organized to raise awareness about the dignity of labor, particularly addressing the challenges faced by the Valmiki Samaj. The play highlighted the value of all professions, regardless of societal rank, and sent a strong message against untouchability, urging the community to promote equality and respect.

This event not only improved access to vital services but also fostered a sense of civic participation and social unity, aligning with multiple Sustainable Development Goals (SDGs), including No Poverty, Clean Water and Sanitation, Gender Equality, and Reduced Inequalities.

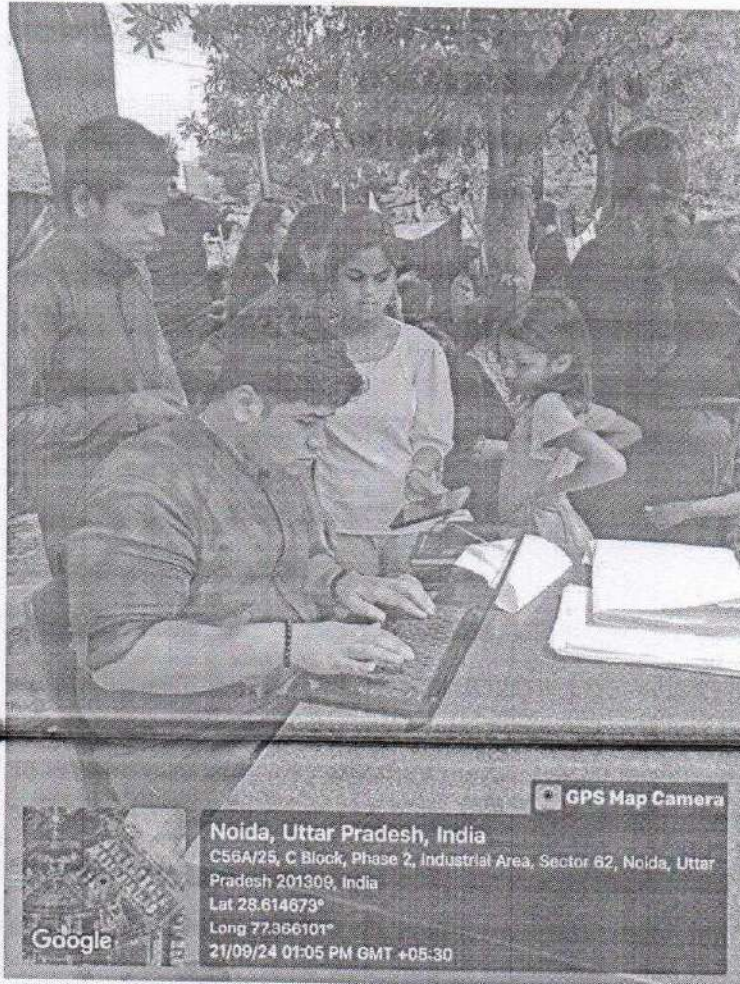



