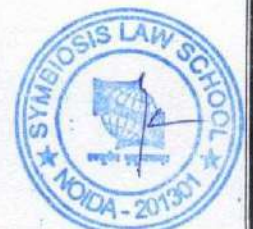

Now in its 4th edition, the event promotes legal awareness and practical legal aid among law students and participants from other disciplines. It serves as a platform to blend legal knowledge with community engagement, emphasizing social justice.

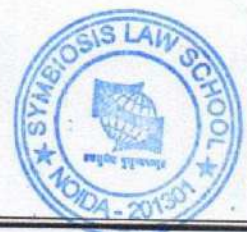
Key competitions include **Create Legal Awareness**, where participants identify legal issues in a mock village through direct interaction with residents, followed by offering legal advice and drafting petitions. **Theru Koothu** (Street Play) encourages teams to creatively raise awareness about legal rights on themes like Right to Education, Cyber Security, and Women Empowerment through performances using song, dance, and theater. Other events, like **Poster Presentations, Mime, and Lights, Law, and Action**, foster creative expression of legal concepts through various artistic forms.

The event also features a **Panel Discussion** where legal experts deliberate on the challenges faced by Legal Aid Clinics and explore innovative solutions. The discussion is open to all undergraduate and postgraduate students from Indian institutions, offering participants valuable insights into the field of legal aid.

LAFESTO aims to enhance participants' legal acumen while simultaneously empowering communities by spreading legal awareness. It encourages students to develop practical skills, advocate for societal change, and compete for recognition and cash prizes.

Team SLS-NOIDA secured the 'Runners-Up' position in both the Street Play and Create Legal Awareness Program, winning Rs. 5,000/- each along with trophies and certificates. In the Poster Presentation, Ms. Saumya Bajpai, Mr. Sayan Majumder, and Ms. Arshita Jain also took the 'Runners-Up' spot, winning Rs. 1,000/-. Additionally, Mr. Sayan Majumder was named 'Mr. Lafesto,' while Ms. Saumya Bajpai and Ms. Arshita Jain earned the title of 'Ms. Lafesto.'

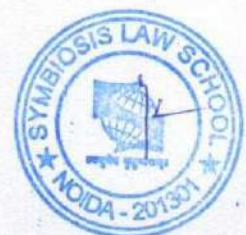


