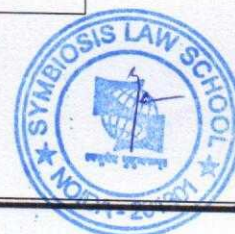

13. Description of Event (max. 250 words)

On 6th October 2024 an on-ground awareness campaign was conducted in a slum area of Kirti Nagar, Delhi, focusing on the underprivileged children, aged 5 to 13. The primary aim of this event was to educate and raise awareness about two important themes: Hygiene and Environment aiming to ensure the health and well-being of individuals and the sustainability of our planet.

On the environmental front, the session through a small skit emphasised the importance of reducing carbon footprints, particularly by curbing plastic waste. The children were introduced to the practice of substituting plastic products and polybags with reusable alternatives such as cloth or jute bags, which are environmentally friendly. Additionally, the campaign advocated for tree planting as a way to combat climate change. We encouraged the children to plant seeds that were readily available in their homes, such as those from fruits and vegetables, to not only contribute to the environment but also to cultivate healthy homegrown food.

On the hygiene front, the campaign addressed personal hygiene practices such as washing hands before meals and after using the restroom, as well as using clean utensils to prevent diseases. The session also

emphasised community hygiene by discussing proper waste management, reusing, recycling, and the segregation of dry and wet waste. The children were moreover taught how vegetable peels can be used to make compost. Moreover, highlighted the steps that can be taken to prevent diseases like dengue, focusing on the importance of not leaving stagnant water exposed to avoid breeding mosquitoes.
