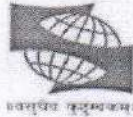
c. Interaction and foster emotional intelligence

12. Description of Event (max. 250 words)

The event conducted by the Legal Aid Centre (LAC) focused on educating children aged 6-10 about good touch and bad touch, fostering body autonomy and effective communication. With growing awareness of child safety issues, this workshop aimed to empower young participants to understand their rights regarding personal space. Facilitators engaged children through discussions, role-playing scenarios, and interactive activities that illustrated the differences between safe and harmful touches. By using relatable examples, they created a supportive environment for children to express their feelings.

Key concepts included the NO-GO-TELL rule, teaching children to assertively refuse unwanted touches, quickly remove themselves from uncomfortable situations, and report incidents to trusted adults. The facilitators also highlighted legal protections, such as the POCSO Act, which safeguards children against sexual offenses and encourages them to seek help confidently. Overall, the event was a vital step in promoting child safety, instilling confidence in young participants, and equipping them with the tools to recognize and respond to unsafe situations, ultimately contributing to a safer community for children.


