I. Concept Note

Dating abuse is controlling, abusive, and aggressive behavior in a romantic relationship. It can happen in straight or gay relationships. It can include verbal, emotional, physical, or sexual abuse, or a combination. dating violence is violence that occurs when teens are in an intimate relationship and it has both short-term as well as long-term consequences. While it's commonly reported in the West, it's a matter of concern in India too with more and more young people getting into relationships at an early age. What's disturbing is that patterns of dating violence. However, with most teens hiding the fact that they may be victims of such violence or even unaware of the magnitude of the issue, parents are often not aware of what's happening. Dating violence can affect both boys and girls irrespective of what their culture, socio-economic background or sexual orientation.

II. Objectives

The main objective of the event was to make the children aware about different issues

like cybercrimes and dating abuse. Also, to make them understand that they can use different methods to tackle this issue. The major objectives are-

- 1. Create awareness among the wards of Air personals about different modern day crimes .
- 2. To make them understand what different methods can be adapted by them to avoid such crimes.
- 3. Also to tell them how they can deal with such a situation if they find themselves in it.

III. Preliminary Preparations

Before conducting the event,

- Selected Air Force Wives Welfare Association(AFWWA) at Air Force Station, 46 Wing Nal, Bikaner as the location for my event as a means to spread awareness among the children of Air Force personals.
- Did a research on the current status of the cyber crimes in India and gained permission from the Air Force authorities in Bikaner to carry out the event at AFFWA.

IV. Conducting the Event

After receiving the permission from the Air Force authority to conduct the event at AFFWA, 46 Wing. I went there with my presentation and ensured that the children became aware of such issues. The presentation focused on different issues which are common among the kids which are cyber crimes and dating abuse. The presentation further focused on dating abuse which can occur in subtle forms as well where the behavior of a person changes due to influence of their partners. Then I went into the in depth analysis of dating abuse and its nuances. I also explained how one can escape from the clutches of such abuse by asking for help, avoid getting influenced by peer pressure, remedies for physical and mental abuse, etc. The legal implications of such actions were also explained in detail. The event was targeted on the age group of 14 - 17 years as it dealt with the issue of dating abuse.

V. Response of the Target Population

After completion of the event conducted on both occasion the response received was quite good. AFWWA has requested that such event be conducted even in the future. They have considered this event to be very informative and have requested that such an event be held if I find myself in Bikaner. In conversation with the kids I found that

many of them are on various social platform from I very young age.

I guided them and made them aware as to how they can avoid such situations and how the shouldn't share the personnel information on social networking sites and the measures they can follow if the find themselves if they are being targeted. Overall, people were responsive and showed interest in talking to me.

VI. Future Plan of Action

As a similar event had already been conducted during the last vacations the crowd consisted of mixed audience some of them were to an extent aware about it. Moreover as the Air Force is already treating the issue of cyber crimes as one of the major issue since it also affects the security of the force so it has taken various campaign. There needs to be more awareness programmes to inform the teens about the evils of drug abuse. Schools and collages should be targeted to create more awareness.

VII. Suggestions/Feedback
