Besides this, they were also informed about the apathy through which persons belonging to third gender have to undergo because of the attitude & behavior of society towards them.

REPORT: SENSITIZING THE SOCIETY TOWARDS THE THIRD GENDER PERSONS

I. Concept Note

Symbiosis Law School, NOIDA has become a celebrated name amongst the aspirants of professional legal education. In its effort to holistically develop the personality of its learners, has formulated various cells, one of them is the Legal Aid Centre. Legal Aid Centre can also be known as centre for providing para- legal services to weaker and unaware sections of the society. The Centre, with new members for the year 2015- 16, conducted two programs. These programs were conducted with objective to create awareness in the society regarding filing of an R.T.I application and sensitization towards the third- gender community.

The event was conducted in Mumbai. One of the tasks was to create awareness and make people sensitive towards the third gender community. Transgender community accounts for lakhs of people in India. They are a part of the society but people consider them out cast and treat them in the same manner. They consider that they have some disease. 57% of them are not supported by their own family and are thrown out. People do not accept them; they are not given treatment in hospitals, etc. Therefore, to make people considerate towards them, the event was conducted.

II. Objectives

The trans- genders, a minority community in India, are considered out cast and are not treated with respect and dignity. This is the case because of stereotypical mentality of the people. The objectives were:

- Make people aware, considerate and sensitive towards this community.
- To tell them that they don't have any disease, it is natural.
- To make them realize that they are also humans with feelings and desires, and treating them with such dishonour devastates them and they lose hope and desire to live.

 It was told that these people neither disturb others nor interfere in others' work and that when they are not creating any problem for us, they why should we make their lives difficult.

III. Preliminary Preparations

For conducting the event, the preliminary work done was:

- Talk to people, regarding where such programs can be conducted.
- Informing the people that such helpful programs are being conducted, therefore they should attend them.
- Talk to your acquaintances and friends for becoming a volunteer.
- Getting posters, pamphlets and banners printed.
- Research, read and prepare yourself for making such presentation.
- Translating few terms and sentences into Marathi, for making it easy for people to understand.
- Make them aware that the law of the country has accepted them and if they are mistreated, it can be considered as a serious offence.

IV. Conducting the Event

I spoke to my supervisor regarding conducting such events, they appreciated the initiative and suggested that the supporting staff, sweepers, cleaners, security guards, etc., can be given such training. They were informed of the same; therefore they came in a presentable manner that day.

The programs were conducted in one of the conference rooms of Idea Cellular Limited, Corporate Office, Mumbai. The C.F.O of Idea Cellular supported in making all the arrangements for the programme.

The event started by giving them a brief description of myself and the organization which I am representing. Then we distributed the pamphlets and posters.

Then brief was given about the trans- gender community in India and the way they are treated in our country. Then the information given in pamphlets were discussed. The people were made to realize that they are a part of society and are not indifferent. They are normal human beings, without any disease or impairment; therefore they should be accepted without any discrimination.

V. Response of the Target Population

The target population was first cynical about the issue and the people of such community, but gradually they started discussing that how such people are treated in their society and families. Such discussion, made them realize that they are doing something very wrong and they can also be penalized for the same. Their opinion changed and they promised that they would not misbehave with them and also make sure that they are not discriminated by anybody.

VI. Future Plan of Action

In future, more sessions should be conducted. One city at a time should be chosen and every corner of the city should be covered. We can also take up a case where people of such community are suffering and we can provide them aid till justice is ensured to him. More workshops should be conducted.

VII. Suggestions/Feedback

The points are:

- More volunteers should work collectively. (At the same place)
- The place where it can be conducted should already be decided.
- There should be collaboration with NGOs or organizations, which work for the same cause.

VIII. Concluding Remarks
The initiative taken up by Legal Aid Centre of Symbiosis Law School, Noida was very wisely
chosen and was appreciated at different levels. This program gave me an opportunity to
conduct an event on my own and speak in front of so many unknown people. It was a
learning experience for me. It helped me gain a lot of confidence. I would like to work for

I. Concept Note

two tasks, in order to create, awareness in the society regarding, filing of an R.T.I application

and sensitization towards the third-gender community.

The event was conducted in Mumbai. The first task was to create awareness regarding R.T.I

and filing of an application. Right to Information is one of our fundamental rights; still there

are many sections of the society who are not aware of such right. The idea behind doing this

programme was to help people know about R.T.I and teach them how to file an R.T.I

application, in cases, when they need some information which is very important to them.

This can also represent transparency of the government. People can ask information

regarding various government and government aided organizations and departments. The

main philosophy behind it was to make people aware of such provision by the government,

which can be used by them, in time of need.

II. Objectives

The programme was initiated to spread awareness about the Right to Information Act,

which was introduced in 2015 as a means to ensure greater transparency and accountability

in the Indian Government and Public Utility Services. The objectives were:

• Make people aware about such an important fundamental right, which can

be very useful to them.

To help them learn, the procedure of filing an R.T.I.

• To empower, strengthen and help them realize that the government authorities cannot make them feel helpless and it also cannot torture them.

V. Response of the Target Population

The target population was glad to know about the topics. They were happy that filing is so easy and that also, at Rs. 10. They also had queries regarding the steps that should be followed if the authority failed to reply within the time period mentioned in the Act, i.e. 30 days. One of them had filed an application and still no proper response had come, therefore he was told how he can make an appeal for the same. There were other queries also. They showed interest in the programme.

VI. Future Plan of Action

In future, more sessions should be conducted. One city at a time should be chosen and every corner of the city should be covered. We can also take up a case where people are suffering and we can provide them aid in filing an application and aid him/ her till justice in ensured to him. More workshops should be conducted. The pamphlets showcasing the 4 steps and other information in brief can be distributed in various areas.
