Teach Legal Writing, Skills, and Values: In that full-year class, students produce a series of objective legal memoranda of increasing complexity. The skills involved in producing these memoranda include understanding the drafting process; conducting legal research; analyzing legal issues; choosing an appropriate organizational scheme for the analysis; writing effective sentences and paragraphs; writing correctly; and revising and editing. In addition, in this class, students are introduced to the lawyering skills of client interviewing, client counseling, fact development, and negotiation. Students also explore the values of professionalism, culture competence, and reflection.

Teach Legal Writing II: In that one-semester class, students produce a trial level brief and an appellate brief. In producing these briefs, in addition to using the skills learned in Legal Writing I, students learn techniques to write persuasively. In addition, students learn oral advocacy skills, and they argue the issues in the brief.
