Apart from teaching the relevant provisions of law, the course may include not less than 15 practical exercises in drafting carrying a total of 60 marks (4 marks each) and 15 exercises in Conveyancing carrying another 60 marks (4 marks each) remaining 30 marks will be given for viva voce. Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International (Deemed University)).

2 The course will be conducted by senior legal practitioners through simulation and case studies. Evaluation will be conducted in practical exercises for 120 marks and viva voce for 30 marks. Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International University).

Vive voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International (Deemed University)).

4 This course will have three components: a. Moot Court (Three moot courts with 10 marks each= 30 marks); b. Observance of Trial in two cases, one Civil and one Criminal (30 marks); and c. Interviewing techniques and Pre-trial preparations and as per the given format, cumulative Internship diary (60 marks). Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition. This will be recorded in a separate diary. In addition to the above three components, the fourth component will be Viva Voce examination on all the above three aspects (30 marks). Vive voce examination will be conducted by a panel consisting of
