5. ELIGIBILITY

The candidate should have passed 12th (10+2) examination from any recognized board with minimum 45% marks (40% for SC/ST students) in one attempt (No Compartment).

Applicants who have obtained 10+2 through Open Universities system directly without having any basic qualification are not eligible for the Law Course.

Age Limit: Candidate should be less than 20 years of age at the time of appearing for SET as on 03 May 2014. (2 years relaxation for SC/ST candidates i.e. 22 years)

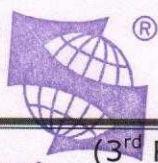

11. ASSESSMENT

All internal courses will have 100% component as internal evaluation at the institute level. All external courses will have 40% internal component and 60% external component [University] examination.

12. STANDARD OF PASSING

The assessment of students for each examination is done, based on relative performance. Maximum Grade Point (GP) is 4.000 corresponding to A+. For all courses, a student is required to pass both internal and external examination separately with a



minimum Grade Point of 2.000 corresponding to Grade D. Students securing less than 40% absolute marks in each head of passing will be declared FAIL. The University awards a degree to the student who has achieved a minimum CGPA of 2.000 out of maximum of 4.000 for the program.

13. AWARD OF DEGREE

Bachelor of Business Administration and Bachelor of Laws (BBALLB) degree will be awarded at the end of semester X by taking into consideration the performance of all semester examinations after obtaining minimum 2.000 CGPA out of 4.000.

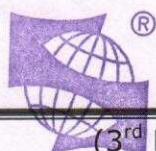

1 The course will be taught class instructions and simulation exercises, preferably with assistance of practicing lawyers/retired judges. Apart from teaching the relevant provisions of law, the course may include not less than 15 practical exercises in drafting carrying a total of 60 marks (4 marks each) and 15 exercises in Conveyance carrying another 60 marks (4 marks each) remaining 30 marks will be given for viva voce. Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International University).

2 The course will be conducted by senior legal practitioners through simulation and case studies. Evaluation will be conducted in practical exercises for 120 marks and viva voce for 30 marks. Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International University).

3 This course will be conducted through class instructions and simulation exercises, in association with practicing lawyers. Evaluation will include written test (80 marks), case study (20 marks), Periodical problem solution (20 marks) and viva-voce (30 marks). Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International University).

4 This course will have three components: a. Moot Court (Three moot courts with 10 marks each= 30 marks); b. Observance of Trial in two cases, one Civil and one Criminal (30 marks); and c. Interviewing techniques and Pre-trial preparations and as per the given format, cumulative Internship diary (60 marks). Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition. This will be recorded in a separate diary. In addition to the above three components, the fourth component will be Viva Voce examination on all the above three aspects (30 marks). Viva voce examination will be conducted by a panel consisting of internal and external members (appointed by the Symbiosis International University).
